
## **Organisational chart**







## **ALBANIA - ENHANCEMENT OF PROTECTED NATURAL AREAS**

### Ongoing projects:

Eco-friendly development for the natural capital of the coasts of Albania (BLUE) - AID 011928
 VITA-Vjosa: Enhancement of Tourism and Environment Initiatives along the Vjosa river basin (VJOSA) –
 AID012590-08-5



#### Context

Albania has a rich natural and biological heritage and the BLUE project has strengthened the role of national and regional institutions and local communities in managing protected areas, with particular focus on water basins. The VJOSA project aims to help developing sustainable tourism and the environmental protection of the Vjosa river basin by enhancing natural resources, promoting the training and growth of small businesses and thus creating jobs.

#### **Implemented in 2023**

- 3 courses on sustainable fishing and sea turtle monitoring
- 2 studies on Himara-Porto Palermo and sustainable fishing
- 6 artificial coral structures were installed
- 1 sea turtle rescue centre was set up
- 3 landfill mappings
- 1 study activity on integrated water management

#### Impact

The most significant legacy of the BLUE project is the rescue centre for sea turtles in Vlorë, a centre of excellence both in the country and in Europe. The project had a significant impact in terms of increasing the awareness of young people and public institutions on the management of waste and water and job opportunities in the environmental sector. The concurrent drafting of specific reports and studies on sustainable fishing has provided key data and information aimed at guiding fishing management policies and promoting more sustainable practices in the sector. In addition, the installation of artificial coral structures for biodiversity had a direct impact on the local marine ecosystem, providing vital habitats for a wide range of marine species.

## **KOSOVO - NATURKOSOVO**



### Ongoing project:

• The natural and cultural capital in Kosovo and the sustainable tourism development of the Via Dinarica – AID 12382





#### Context

The project aims to help develop sustainable tourism in Kosovo by promoting the local section of the Via Dinarica (120 km through the Accursed Mountains Park), by enhancing its cultural, historical and natural resources, supporting institutions in managing the sector and creating jobs for the benefit of local communities.

#### **Implemented in 2023**

- 2 means of transport were equipped for tourist transport
- 688 environmental and disaster management kits were purchased
- 1 digital data processing and transfer system, which ensures the connection with the CAI open source system

• 3 meetings were organised for children and teenagers on environmental issues and on the resources and opportunities offered by the Accursed Mountains Park

#### Impact

In 2023 CELIM's activity in Kosovo focused on training 67 technicians involved in mountain tourism and safety. Thanks to the collaboration of CAI and the Italian Alpine rescue, the enhancement of the country's natural heritage through competent technical interventions aims to offer job opportunities and lay the foundations for the development of tourism in the area.

### **NORTH MACEDONIA - ENCOURAGING THE INCLUSION OF THE ROMA POPULATION**

## Ongoing project:

Ensuring decent living conditions for the Roma population of the municipality of Prilep (SDLR) – IPA/2020/168111/12







#### Context

In North Macedonia live 54,000 Roma, one of the largest ethnic minorities. Often marginalised by Macedonian society, this ethnic group lives in precarious conditions and with no real integration opportunities. The project aims to improve the living conditions of the Roma community in the enclave of the city of Prilep, through the regularisation of their settlements and the redevelopment of private homes and infrastructure.

#### **Implemented in 2023**

- 65.8 hectares of urban area were regularised
- the current town planning documents of the Municipality of Prilep were examined and updated
- 202 homes were regularised within the Roma enclave
- 11 houses were renovated and 5 rebuilt

#### Impact

So far, 4,684 people residing in the Roma enclaves of Prilep have legally moved to an area registered and authorised by the DUP (Urban Planning Document); 3,049 people have benefited from the regularisation of housing or are on the waiting list for new applications; 163 people live in renovated homes.

On the initiative of the project, the Ministry of Health has launched a health intervention plan within the Roma enclaves in order to provide easier access to basic health services to the local population.

#### Context

Large quantities of oil are produced in southern Lebanon. Yet, an important part of this product remains unsold due to its poor quality and high costs. Furthermore, the waste from the supply chain's processing is poured into rivers or over agricultural land. The resulting environmental situation is unsustainable. The DOT Olive project helped improve production efficiency and created a stable access to foreign and domestic markets, thus reducing the environmental impact. Also focused on the environment, the WASTE project aims to help reduce the negative impact on health and the environment. Work is being done to empower the population to manage waste and improve the system for its collection, treatment and disposal. In addition, the project aims to introduce innovative and sustainable production systems, creating respectable jobs in the waste supply chains.

#### **Implemented in 2023**

- 5 courses for municipal technicians on waste management and characterisation
- 1 collection plan in Rashaya Al Foukhar was revised and streamlined.
- 20 companies were selected for the development of sustainable activities
- the Hasbaya composting system started processing 0.1 kg/inhabitant/year
- 1,000 litres of oil were sold in Japan and 4,000 in Germany
- management autonomy of the oil bottling plant

Despite the conflict affecting the area, CELIM managed to complete the DOT Olive project, finishing the bottling plant in Hasbaya and opening local as well as international commercial channels, thus guaranteeing the company's sustainability in favour of 109 olive growers. On the other hand, the commitment on the WASTE project had to be reduced and restricted to the safest areas only; despite this, the first steps were taken towards the creation of landfills and composting centres and to launch awareness campaigns on waste management

## **KENYA – SUSTAINABLE AGRICULTURE AGAINST CLIMATE CHANGE**

### Ongoing projects:

• Efficient greenhouses in the county of Laikipia - 2021-3154

• Caffè corretto: development of a sustainable, inclusive and innovative coffee supply chain – AID 012590-07-9



#### Context

In the Laikipia County, water shortages, hard-to-cultivate land and climate change do not offer strong prospects to farmers who, through the Efficient Greenhouses project, have been offered alternative production activities to improve the economic conditions of local communities. Likewise, the Caffè corretto intervention aims to promote a quality sustainable, climate-conscious agricultural model for the coffee production chain in the Kiambu and Embu counties, which will increase the income of over twelve thousand producers gathered in four cooperatives.

#### **Implemented in 2023**

- 1 cottage was extended at the Laikipia Permaculture Centre
- 500 copies of 1 tourist guide were printed
- 1 training course on hospitality and group reception was provided to staff
- 1 video/documentary was made about the project
- 4 coffee demonstration fields were created
- 265 agricultural kits, 25,000 coffee plants and 800 trees were distributed
- 1 laboratory was equipped to manufacture coffee processing by-products
- 8 training sessions were held for agronomists, farmers, county representatives
- 2 studies were carried out on soil quality and coffee beans

#### Impact

In 2023 the greenhouse project was completed, with an increase in revenues from product trade: 139% cosmetic products; 70% honey; 3% products with Opuntia; and a 60% increase in income from tourist reception activities.

### **MOZAMBIQUE - RURAL DEVELOPMENT AND ENVIRONMENTAL PROTECTION**

### Ongoing projects:

• Resilient Youth for a Sustainable Future (JUVEM) - EuropeAid/166712/DD/ACT/MZ • Honey, fishing and nutrition. Reduction of food insecurity in the populations of the districts of Caia, Luabo and Mopeia–189



#### Context

Zambezia is one of Mozambique's poorest provinces. 88% of its population works in agriculture and about a third is aged between 15 and 35 years. The objective of the JUVEM project is to train boys and girls, by developing agricultural economic activities and involving them in the correct management of the natural resources. The project "Honey and Fishing", on the other hand, focuses on strengthening food security for vulnerable groups in the area through nutritional education, beekeeping and river fishing.

#### Implemented in 2023

- 23 between beehives, ponds and nurseries were set up
- 1 house of Honey was created
- 1 renovation of the Boroma school was completed
- 12 ovens and 14 dryers were installed
- 82 agricultural kits and 4 natural disaster management kits were distributed
- 12 fishing nets were distributed
- 15 bicycles and 2 boats for fishing centres were distributed
- 23,190 mangrove seeds and seedlings were planted over 23 hectares
- 29,180 fries were distributed among the ponds
- 60 professional and short courses were organised on agricultural, breeding and disaster management techniques
- 30 awareness-raising initiatives were carried out

#### Impact

- 359 pupils with improved technical skills in beekeeping and fish farming
- 200 young people were practising fish farming and beekeeping
- 52 kg of honey and 272 kg of fish were produced
- 180 members of civil protection groups with improved natural disaster management skills
- 46.32 hectares were reforested with mangroves
- agro-forestry systems were installed on 12 hectares
- 510 community members active in good natural resource management practices
- 92% of the women beneficiaries improved their skills and habits in food and hygiene practices
- 22% increase in annual catch per fisherman

## ZAMBIA – BY THE SIDE OF THE MOST VULNERABLE

## Ongoing projects:

• Social inclusion of street children and young inmates (C4Y) - EIDHR/2020/166162-1/13,254/2021 • EduCare: inclusive actions to protect the rights of children with disabilities in Zambia (EDUAC) CSO - LA/2021/428-589







#### Context

In Zambia, street children and children who have committed crimes are not allowed to attend school, nor have they access to recreational activities. Young people with disabilities are often stigmatised and cannot easily access educational, health and work services, in a context where there is a shortage of teachers and qualified workers. The projects offer educational and professional training and art and sports activities to street kids, young inmates and young people with disabilities. The interventions, which also include the improvement of the infrastructures and services of the centres that welcome them, promote their work inclusion and reunification with their families of origin.

#### Implemented in 2023

- 1 chicken coop, 1 pigsty and 2 fish ponds were created
- 700 kg of corn and vegetables were produced, 6,016 chickens and pigs were reared
- 1 epilepsy clinic was opened; 6 school facilities, 1 sports field and 1 day centre were refurbished
- 183 school kits, 40 sanitary kits, 1,276 meals were distributed
- 88 street education interventions, 183 health check-ups, 229 family and community reintegration activities
- 55 professional scholarships were provided
- 31 professional and short courses to better manage street children or children with disabilities were held.
- 20 inclusive educational paths: literacy, theatre, sport, music, reading
- 102 community outreach activities in schools, parishes, businesses, also through radio interventions

#### Impact

- 183 street children were reintegrated into the school system and into their families and communities
- 76 juvenile inmates were reintegrated into society
- 524 children and young people with disabilities had access to educational, recreational and social services
- 10 schools benefited from teacher training and inclusive activities
- 436 families of children and young people with disabilities benefited from socio-economic activities

#### Context

The activities offered to schools integrate teaching with the themes of rights and citizenship. The methodology entails participatory lessons with theoretical reasoning, simulation games and manual workshops. The aim is to stimulate good practices aimed at improving the local and global context. CELIM is also active with after-school activities and by teaching Italian as a second language.

#### Implemented in 2023

- 3 Italian language courses for newly arrived foreign girls and boys




## **EFFECTIVENESS INDEX**

We carried out the audit of the financial statements of CELIM – Onlus, consisting of the balance sheet as at 31st December 2023, the management statement for the year ended on that date and the 'general part' and 'explanation of the accounting entries' sections included in the mission report. The aforementioned financial statements were prepared in compliance with the Italian regulations governing the criteria for their drafting.

In our opinion, the financial statements provide a true and fair view of the financial position of Ce.L.I.M. - Centro Laici Italiani per le Missioni – Onlus as at 31st December 2023 and of the profit/loss figures for the year ended on that date, in accordance with the Italian regulations governing the drafting criteria.

Elements on which the opinion is based

We carried out the audit in accordance with international auditing standards (ISA Italy). Our responsibilities under these standards are further described in the paragraph titled 'Responsibilities of the auditors for the audit of the financial statements' of this report.

We are independent from Ce.L.I.M. - Centro Laici Italiani per le Missioni – Onlus, in accordance with the rules and principles on ethics and independence applicable in the Italian legal system to the audit of financial statements.

We believe we have acquired sufficient and appropriate documentary evidence on which to base our opinion.

Responsibility of the Board of Governors of CELIM - Onlus for the financial statements

The Board of Governors is responsible for assessing the ability of the Entity to continue operating as a functioning entity and, in the preparation of the financial statements, for the appropriateness of the use of the assumption of going concern, as well as for adequate information on the matter. The Board of Governors uses the going concern assumption in the drafting of the financial statements unless it has determined the existence of grounds for the termination or dissolution and consequent liquidation of the Organisation or conditions for discontinuation or has no realistic alternative to these choices.

Responsibilities of the auditors for the audit of the financial statements

Our goals are to obtain reasonable assurance that the financial statements as a whole do not contain significant errors, whether due to fraud or unintentional conduct or events, and to issue an audit report that includes our opinion. Reasonable assurance is defined as a high level of certainty which, however, does not provide assurance that an audit performed in accordance with the International Accounting Standards (ISA Italy) will always detect a significant error, if any. Errors may arise from fraud or unintentional conduct or events and are considered to be material when they could be reasonably expected, either individually or collectively, to influence the economic decisions made by users on the basis of the financial statements.

As part of the audit carried out in accordance with international auditing standards (ISA Italy), we exercised professional judgment and we maintained professional scepticism throughout the audit. Furthermore:

• We identified and assessed the risks of significant errors, due to fraud or unintentional conduct or events in the financial statements; we defined and carried out audit procedures in response to these risks; we acquired sufficient and appropriate audit evidence on which we based our opinion. The risk of not detecting a significant error due to fraud is higher than the risk of not detecting a significant error resulting from unintentional conduct or events, since fraud may imply the existence of collusion, falsification, intentional omissions, misrepresentation or forcing of internal control;

• We have acquired an understanding of the internal control relevant for auditing purposes in order to define suitable audit procedures in the circumstances and not to express an opinion on the effectiveness of the internal control of the Organisation;

• We have assessed the appropriateness of the accounting principles used and the reasonableness of accounting estimates made by the Board of Governors, including the related disclosure;

• We have reached a conclusion on the applicability of the use by the Board of Governors of the assumption of business continuity and, based on the audit evidence, on the existence of any significant uncertainty regarding events or circumstances which may give rise to significant doubts on the Organisation's ability to continue operating as a functioning entity. In the presence of significant uncertainty, it is our duty to call attention to the related financial statement disclosures in the audit report, or, if such disclosures prove to be inadequate, to reflect this fact in the formulation of our opinion. Our conclusions are based on the evidence acquired up to the date of this report. However, subsequent events or circumstances may result in the Organisation ceasing to operate as a going concern;

• We have evaluated the presentation, the structure and the content of the financial statements as a whole, including the report, and whether the financial statements represent the underlying transactions and events in order to provide a correct representation;

We communicated to those in charge of the governance activities, identified at an appropriate level, as requested by the ISA Italy, among other aspects, the scope and timing planned for the audit and the relative significant results, including any significant internal control weaknesses identified during the audit.
